Refunds will be made upon written request if received before March 15, 2018. Badges and confirmation materials must be returned with the cancellation request. All cancellation requests are subject to a \$20 handling fee.

PARKING DESCRIPTIONS

GENERAL PARKING – Use of generator permitted from 6 a.m. to 11 p.m.

ELECTRIC PARKING – For those who register for 30-amp and 50-amp electric at their sites. Electric will be available at your parking space on the date indicated on your "date of entry" card. Electric will be turned off at 9:00 a.m. on Monday, March 19, 2018.

FULL GENERATOR – Generator permitted 24 hours per day.

NO GENERATOR – Space is limited.

DISABILITY PARKING – Reserved for those with qualifying medical needs. Space is limited and will be assigned on a first-come, first-served basis. **Please send a copy of you state-issued disability parking certificate to the national office if it is not already on file.**

PASSPORT CAR PARKING – Includes entertainment, exhibits and seminars. No overnight parking on event property. Passport coaches cannot be accommodated at the fairgrounds. Passport car parking will be open only until 10 p.m., March 13, 14, 15, 16, 17, and 18, 2018. Public parking will be open only during exhibit hours, March 15, 16, 17, and 18, 2018.

CARAVANS – Scheduled caravans of 10 coaches or more will be parked on Tuesday and Wednesday, March 13 and 14, 2018. Caravan leaders please call 800-543-3622 to schedule an arrival time.

By registering for this event I understand that I must carry valid insurance on my personal mobility cart and/or personal golf cart during the event.

FMCA PAYMENT PLAN

The FMCA Payment Plan is available for those who register by credit card. This plan allows registrants to pay half of the total registration costs upon initial registration, with the balance charged at a later date. For those who elect to use the Payment Plan for the Perry convention, the balance will be charged on January 17, 2018.

VOLUNTEER

MAILING AND PARKING PROCEDURES FOR ALL PARKING AREAS

FMCA will begin mailing confirmations as soon as January 25, 2018. Mailed confirmations will contain "date of entry" credentials. Mailed registrations received after March 1, 2018, will be held and processed as gate registrations.

If it is impossible for you to furnish an address for receipt of your confirmation material, they will be held for you at Will Call located at the official Holding Area from 8 a.m. – 5 p.m., Monday, March 12, through Thursday, March 15.

Registered family members will be assigned parking dates of Tuesday, Wednesday, and Thursday, March 13, 14, and 15, 2018, and families should arrive at the convention on the date stated on their "date of entry" credentials. If you arrive at the convention on a date before or after your assigned date of entry, you may have to wait in the Holding Area to be parked.

If you would like to park with family or friends during the event, you must register for the same type of parking and have the same arrival date. Also, you must arrive together, or wait in the Holding Area until all parties have arrived, so you can be parked together.

Convention parking is considered any lot secured by FMCA. Members of FMCA's parking team will be in the Holding Area from 8 a.m. to 5 p.m. to park coaches. Tram service to all parking areas will be available beginning Wednesday, March 14, 2018.

If you are traveling as an individual, a group, or a caravan, confirmation "date of entry" credentials must be displayed on your motorhome to facilitate your entry into the grounds.

Parking will be located at the Georgia National Fairgrounds & Agricenter. Parking will be at the discretion of the parkers.

Departure day is Monday, March 19, by noon. Electric will be turned off at 9:00 a.m.

EARLY ARRIVALS

If you arrive prior to your date of admittance, as identified on your "date of entry" credential, dry camping will be available beginning on Monday, March 12, 2018 in the Holding Area.
